#### (D) Minutes of the Meeting (Proceedings):

#### The Agenda Items for Consideration:

**Item No. CVRU-IQAC-27A1:** Review and Approval of the previous 26<sup>th</sup> IQAC-meeting held in Online mode.

**Res:** The minutes of the previous meeting of IQAC was read successfully and was unanimously confirmed. The resolutions made were presented and circulated/communicated to all the members.

**Item No. CVRU-IQAC-27A2:** Review of the Action taken Report of the previous 26<sup>th</sup> IQAC meeting held before in online mode via Google-Meet platform.

**Res:** Towards reviewing of the action taken report of the previous IQAC meeting, it was decided by IQAC to resolve and confirm the same by all members present and thereafter communicated to the Chair for further approval.

**Item No. CVRU-IQAC-27A3:** Proposal for the updating & revamp of the University website in accordance with the advanced requirements and new norms of web-page-designing as per UGC guidelines.

**Res:** The proposal for the upgradation and revamp of the University website was proposed by Dr. Saurabh Mitra, Asso. Prof, ECE & CVRU-Website Coordinator as per the keen requirement of NAAC and the need of the hour for facilitating better Online & ICT-enabled services & E-resources for CVRU Stakeholders. Moreover, it was also discussed to maintain a webpage on the CVRU website for lodging complaints of caste-based discrimination. The IQAC decision was to resolve and approve the same for further confirmation by the Chair & all the members present.

**Item No. CVRU-IQAC-27A4:** Proposal for the Approval of New Programs and New Courses in the current academic session of 2020-21

**Res:** As per the proposal given by the Department of Law, one new program viz. B.Com LLB is introduced during the current academic session of 2020-21 for which the curricula has been designed accordingly and prepared with the guidelines of BCI & UGC.

**Item No. CVRU-IQAC-27A5:** Proposal for the incorporation & use of Virtual Labs in Science & Engineering Programs for Remote students in view of COVID-19 Pandemic situation.

**Res:** The Dean Academics of CVRU proposed to incorporate the use of Virtual Labs in the Science & Engineering programs for enhancing the better learning experience of Laboratories for the students in remote areas during the present pandemic status. Keeping this in view Several virtual Labs were identified vi. MMERLOT labs, Praxilabs, Labster, ChemLabs and also listed from the available database of IIT-Kharagpur, Amrita-Vishwa Vidyapeetham, IIIT-Hyderabad etc to enable students and teachers performing the practical experiments in virtual mode.

**Res:** Keeping in view the non-availability of students for the practical classes in offline mode as per the guidelines of the state Govt. during the current Pandemic Scenario, it was proposed by the Dean Academic of CVRU to incorporate the virtual labs and new and advanced ICT-based practical teaching tools for the laboratory classes of Science and Engineering faculties to teach via the University LMS (I-Track Global) to enhance the better learning environment and teaching skills. It was discussed and resolved to approve and further was unanimously confirmed.

**Item No. CVRU-IQAC-27A6:** Introducing New Value-Added courses and skill courses outside the curriculum for value addition, ability enhancement & skill enhancement of CVRU-Students.

**Res:** The 6 Academic departments viz. Commerce-Management, Linguistics, Social sciences, IT-CS, Education & dept. of Rural Technology introduced 8 new value added courses to be offered for the current academic session in 2020-21 and designed its syllabi accordingly for better value addition and skill enrichments among its students..

Item No. CVRU-IQAC-27A7: Proposal for Renewal & betterment of the University Community Radio

**Res:** The CVRU Community Radio (Radio-RAMAN-90.4) is one of its unique and was the first to be established in the State of Chhattisgarh in any University. Hence, it was proposed by the CVRU Broadcast-Coordinator to renew, enrich and upgrade the radio-contents for better broadcast in nearby community areas with more varieties of short stories inspirational and motivational episodes, educational episodes, health & hygiene awareness programs etc. It was discussed and unanimously confirmed by all members present and was resolved to approve the same.

Item No. CVRU-IQAC-27A8: Proposal for Discussion on Action Plan for NEP2020 and its implementation.

**Res:** The discussion was made with an objective to elicit action points and activities under NEP 2020 considering the aspects of the policy of which the C.G State considers which is amendable upto implementation regarding which a meeting at CVRU is to be convened by CVRU-NEP Task-Force in the upcoming days very soon. The objective of the meeting must be an aligned & structured discussion on NEP 2020 in a systematic manner. The IQAC decision was to resolve the same for further approval.

**Item No. CVRU-IQAC-27A9:** Incorporating research & Publication Ethics as a mandate in Ph.D Course work

**Res:** As per the UGC guidelines vide letter dated 26/12/2019, the incorporation of the 2 credits course of **Research and Publication ethics** was made mandate in the Ph.D Course work of research programs offered by the University(HEI's). Keeping this in view the Coordinator research of CVRU proposed the same for the Ph.D Scholars of the current academic session and being implemented in the scheme of research curricula regarding which the syllabus has been designed for both theory and practical portions according to the UGC guidelines of research ethics. Although, the implementation of the Research & Publication Ethics has already been done in the M.Phil Program of CVRU during the previous years. The decision was resolved to approve & get confirmed by the Chair.

**Item No. CVRU-IQAC-27A10:** Conducting several University Audits viz. Academic & Administrative Audits (AAA), Green Audit, Eco Audit, Energy Audit, Gender Audit, Health & Fitness Audit etc & some other special audits & the finalization of its Funds.

**Res:** The CVRU Audit Committee kept the proposals for several CVRU Audits to be performed by the IQAC as a Quality mandate during the current academic session of 2020-21 for which the audit-Performa was made, audit-mechanisms were prepared and discussed. CVRU interacted and consulted the ISO-Certified Lead auditors of India including the Nature Science Foundation (NSF), The Grand academic Portal (GAP), The Grand Academic Assessment Consortium (GAAC) etc. to perform the quality audits. The resolution was made to approve and confirm the same by the Chair for further discussion on the mobilization of relevant funds by IQAC.

Item No. CVRU-IQAC-27A11: Revision in some university Policies, procedures and guidelines as per current academic scenario and UGC Guidelines.

**Res**: Looking after the current changing scenario and rapid academic reforms in the procedures and policies of the Higher Education Institutions across the Nation, the CVRU Strategic Planning

committee & IQAC decided to revise its pre-defined policies & procedures and would make some minor amendments and modifications in its several policies, manuals, handbooks etc. including its revised Mission & Vision statements. The resolution was approved and unanimously confirmed.

Item No. CVRU-IQAC-27A12: Reformation & Reconstitution of University Clubs, Committees, Cells & Centers & establishing of some New Centers, clubs & Committees.

**Res:** For carrying out the smooth functioning and activities of the CVRU Clubs/committees/cells/centers throughout the session involving the maximum student participation, the DR Establishment of CVRU Dr. Laxmikant Tiwari proposed to reframe, restructure and reconstitute certain cells/clubs/committees/centers of CVRU and add some new active members for the upcoming session eg. EBSB Club (Ek Bharat Shreshtha Bharat Club), Eco-Club, Research and Advisory Committee (RAC), IIC, DRIC, URIC, LAC, ICC, Students Grievance Redressal Cell, Anti-Ragging Committee etc. Further, 8 new Centers and CoE's were also constituted and established in the University (List Enclosed in Annexure).

**Item No. CVRU-IQAC-27A13:** Organizing various events at CVRU viz. E-Seminar/ Conference/ workshops/ FDP's/ webinars/PDPs/ talks /symposia/training/ by academic depts & IQAC **Res:** Various Events were proposed to be organized as per the yearly Activity Calendar and Activity Plan of CVRU viz. "Two Day-Symposia on Physical Fitness & Psychological Awareness with respect to current Scenario is going to be organized by dept. of Physical Education & IQAC from 7<sup>th</sup> to 8<sup>th</sup> August, 2020. Several departments reported that they have organized many more events during the previous two months (List enclosed in Annexures).

The meeting ended with the vote of thanks proposed by Dr. Jayati Chatterjee Mitra, Coordinator, IQAC-CVRU.



#### The Agenda Items for Consideration:

Item No. CVRU-IQAC-28A2: Review of the Action taken Report of the previous 27th IQAC meeting.

**Res:** For reviewing the action taken report of the previous IQAC meeting, it was to resolve and approve the same by all the members present. The AT report was confirmed approved by all.

Item No. CVRU-IQAC-28A3: Submission of AQAR-2019-20 and submission status.

**Res:** Discussion was made on the preparation of the data for submission of AQAR-2019-20 and the details regarding the data collection, preparation, analysis, finalization & submission status was sought.

**Item No. CVRU-IQAC-28A4:** Approval of the reward scheme, funds & incentives to the Teachers of the Departments for their Academic Achievements, awards & research achievements.

**Res:** The academic achievements of all the teachers were discussed towards their state/national/international recognitions in the areas of publications, awards, patents, innovations etc. and thereby the University-reward scheme was approved as per the policy and IQAC letter of recommendation released for the sanction of funds and monetary incentives and certificates of honour to all the selected teachers of the previous academic session.

**Item No. CVRU-IQAC-28A5:** Proposal for purchase of New Plagiarism check software in Indian Languages.

**Res**: It was discussed that the Plagiarism-check software of the University viz. URKUND as approved by UGC is found to be unsuccessful in the plagiarism check of the contents relevant to Hindi and Sanskrit. So, to examine this, it was decided that the thesis/dissertations of Hindi & Sanskrit may be accepted for valuation without the stipulated software plagiarism check only after obtaining an affidavit from the supervising teacher that the research work is original and work undertaken is genuine. To sort out this issue, University needs to examine the purchase of appropriate software for plagiarism check in Indian languages. Thus, it was proposed and resolved to approve the same.

**Item No. CVRU-IQAC-28A6:** A Proposal by the Professional development & Training Cell of the University (CVRU) for organizing Training programs & upskilling programs for the Teaching & Non-Teaching staff Members of CVRU.

Res: It was proposed by the Head of the Professional development & Training Cell of CVRU that a list has been prepared for organizing various upskilling and training programs all the CVRU staff members and it was resolved that the report is approved as per the policy of the University, as presented in here shall be affected in force as suitably confirmed by the members present.


#### Item No. CVRU-IQAC-28A17: Preparation of DCF for submission to AISHE:
